STATEMENT OF INTEREST AND OF THE POSITION OF THE STATE OF NEW HAMPSHIRE

Pursuant to 18 C.F.R. § 385.214(b), the State respectfully sets forth the following interests and position in the above-captioned proceedings.

The boundary between the State of New Hampshire and the State of Vermont lies along the western shore of the Connecticut River. Accordingly, all of the waters, bed and eastern bank of the Connecticut River are part of the State of New Hampshire. The State holds the waters of the Connecticut River in the public trust. Each of the hydroelectric projects subject to this relicensing proceeding (Bellows Falls, Wilder and Vernon) (collectively the "Projects") impounds and utilizes the waters of the Connecticut River to produce electric power that is sold into the ISO-New England regional power market.

The State has an interest in the overall allocation of economic costs and benefits arising from private utilization of the State's public water resources. This broad State interest is separate from the specific interests managed by State resource agencies. The State's direct interest in these proceedings cannot be adequately represented by any other entity. Therefore, the State requests intervenor status in these proceedings so as to protect the foregoing interests and to take a position in the above-captioned proceedings consistent with the foregoing interests.
